Potential places that this fund could be directed would be toward congregation members who have financial needs due to the economic changes resulting from the COVID 19 shut down. The topic was thoroughly discussed and it was decided that while this was a worthy idea that the existing Pastors Discretionary fund served this purpose and at this time there was not a need for a second fund.

Dan noted that he had heard from Paul Boulware of the Family Network about the Yolo county foster system he is looking to place young people and volunteers who might be interested in receiving training about this program.

Dan noted that for the next four Sundays he will be teaching a course for the adult forum. There were suggestions about how to better advertise this sort of thing, announcements during daily devotions and at the end of online services were examples.



## **Pastor's Report to Council**

Lutheran Church of the Incarnation Pastor Dan Smith April 21, 2020 – Zoom Call

## Action Items:

- Shall we establish a task force for reopening the church? Decisions must follow state guidelines and consider not only dates but also practices to keep the congregation safe. Task force could report back in May recommendations. In the meantime we will continue online worship as we have been doing.
- Shall LCI establish a COVID-19 special fund to receive \$1,200 gifts from church members who may want to donate them? Its purpose would be for specific mission causes, which we could decide tonight: e.g. donate to Amor 365, Yolo Food Bank, etc. We could decide that as a Council or ask Social Justice or another sub group to decide.

## Background information:

- Criteria for reopening the church should follow state guidelines and consider not only dates but also practices: e.g. social distancing (setting up chairs proper distance from one another), passing of the peace (no handshaking), how to share communion safely, plenty of hand sanitizing stations, etc. An issue might be how to "enforce" new rules about social interaction that might spread disease. This is a question of risk management that is independent of whatever date we decide to gather again. A task force should include the pastor and people like Craig Lundgren and either Kevin or Lee Grayson or both (note Kevin is an epidemiologist and Lee works as a dental hygienist, so is in a very high-risk profession).
- "COVID-19 fund". An apology may be in order here to the Executive Committee since a letter went out mentioning a discussion that never quite happened. Vern Holmes' letter suggests that seniors or those who do not need them (and *only* those who do not need them) donate some or all of the \$1,200 checks the government will send. Among other things, the money could go to support Amor Ministries, the Yolo Food Bank or other relief work in the community. Note that if we do *not* establish such a fund, people could still choose to donate to the church and/or direct the funds toward a specific mission project.

## Information Items:

A *lot* has changed in the last month! Here's what the staff is doing:

- Weekly services posted to YouTube; bulletins posted to LCI website.
- Pastor's Daily Devotions.
- Weekly staff meetings, followed by Wednesday Weekly updates to congregation by email.
- I will teach a Zoom Bible study at 11am the next four Sundays
- Lindsey and I are teaching a condensed Confirmation class last Sunday and the next two Sundays.
- Lindsey is leading a Zoom youth gathering; working on how to present quilts to HS seniors.

- Jeff S. is preparing music at home and participating in worship planning in Zoom staff meetings.
- I am checking and routing mail, writing thank you notes to people donating, calling church members; I have delivered a few laptops to seniors who don't have tech (still have one available, if you know of a need!). And providing pastoral care, especially for those who are sick and dying (we have a few, although no COVID-19 cases that I know of).

## What you can do:

- If you haven't already, visit our Facebook page and click "like" that will help raise the online profile of our church.
- Tell others about daily devotions and Sunday worship services.
- Let me know if you have pastoral care needs or interests.
- Be prepared for a long haul; this may go on longer than any of us anticipates or would like.

# In the Wider Church/in the community:

- The Synod Assembly has been postponed to the Fall, probably **the last weekend in September, 2020 in Fresno.** Kenny and Courtney Doss have agreed to attend; unsure about how this will unfold will keep you posted.
- Family Hope Network seeking support from congregations in Yolo County for children in the foster care system who will ultimately return to their families. Learned about this on a call today with Paul Boulware. Plan to share information with SJ committee and with congregation for those who might be interested.
